### 1) Artwork must be submitted to: [art@cfanh.org](mailto:art@cfanh.org)

**Email 3 Jpeg images\*** of your artwork and your website address (if you have one)

**Your 3 images should be labelled as follows:**

Last name\_Number on Entry Form\_Title\_AIH24

For example: Smith\_1\_Morning Fog\_AIH24

\*Jpeg images should be approximately 4x6" 300 dpi and ready for printing in promotional materials if accepted.

### 2) Jury Form and Jury Fee Payment:

Your submissions will not be juried until your jury fee payment is received.

### **If Accepted:**

**1) Secure, you will receive a form and link to secure your spot with a \$50 Deposit.** Space is limited. Sites will be assigned on a First Come/First Served Basis

**2) By May 15th:** Send in your Registration Form\*\* and the balance of your site fee payment\*\*\* to confirm your participation and to be included in all promotional materials.

**CFA Membership:** If you wish to become a 2025 member of the Center for the Arts at the time you register, please choose the proper payment option in the drop down menu online, or add \$50 to your payment by check (CFA Membership runs May-May).

### **Important Dates to Remember:**

**May 1st:** Jury Application Form, \$30 (\$25 CFA members Jury Fee payment, and 3 images must be received

**May 15th:** AIH Registration Form\*\* and Balance of Site Fee Payment\*\*\* must be received: \$110 ( \$100 CFA members If you wish to become a CFA Member at this time, please choose the proper option online, or add \$50 to payment by check.

**June 30th:** Orientation Packet will be sent to participants with tent site number.

**July 12th:** Arts in the Harbor set up, prior to 9:30am and break down, after 3:45pm.
